

Disease carrier: an animal that has been infected for a period longer than 3 weeks and which therefore may spread the infection to the other animals. For example in veal calves: Salmonella, Mycoplasma and bovine viral diarrhoea virus (BVDV).
Delayed elimination: the animal is kept for a certain amount of time after detection, but will be eliminated as soon as a certain condition is met. For example a cow in lactation will only be eliminated after the lactation has ended.
